COURSE DESCRIPTION:

Anatomy and Physiology 12 is designed to provide an overview of human anatomy and physiology from the molecular to the organ system level, with an emphasis on the relationship between a body organ's structure and its function towards maintaining homeostasis.

BIG IDEAS:

Homeostasis is maintained through physiological processes.

Gene expression, through protein synthesis, is an interaction between genes and the environment.

Organ systems have complex interrelationships to maintain homeostasis.

CORE COMPETENCIES:

A Core Competency is a skill that all learners need to have to be successful in all aspects of their life. There are 3 core competencies: Communication (Communicating & Collaborating), Thinking (Critical Thinking, Creative and Reflective Thinking), Personal (Personal Awareness and Responsibility, Social Awareness and Responsibility and Positive Personal and Cultural Identity).



COURSE EXPECTATIONS:

- The self-paced nature of this course requires that students manage their time effectively to complete the course by the deadline (typically a year from the date of registration). Successful students make a weekly schedule to plan out the completion of the course.
- Students must read all the information and attempt all activities in the course to be successful in the course.
- Students must take care that their communication with the teacher and with other students through email or in person, is course related, clear and respectful.
- Students must take care that their work is their own and not plagiarized from any other source. This includes previous work submitted for another course, other people's assignments, Web or other resources etc.

- Exercise a healthy, informed skepticism and use scientific knowledge and findings to form their own investigations to evaluate claims in primary and secondary sources
- Consider social, ethical, and environmental implications of the findings from their own and others' investigations
- Critically analyze the validity of information in primary and secondary sources and evaluate the approaches used to solve problems
- Assess risks in the context of personal safety and social responsibility

Introduction Assignment

The Assignment **will cover the following Learning Outcomes (Curricular Competencies)**

- Construct, analyze, and interpret graphs, models, and/or diagrams.
- Use knowledge of scientific concepts to draw conclusions that are consistent with evidence.
- Analyze cause-and-effect relationships.

These are 3 of the 30 learning outcomes in the course curriculum, which comprises 10% of the course Learning Outcomes/Activities. (3/30 = 10%)

UNIT OVERVIEWS AND LEARNING ACTIVITIES:

Unit 1: An overview of organic molecules

Unit 1 is broken down in 6 sections: (1) Water; (2) pH; (3) carbohydrates; (4) lipids; (5) proteins; and (6) nucleic acids.

Big Idea: The building blocks of our body are cells and biological molecules.

Core Competency: *Communication, Thinking, Personal and Social competencies.*

First Peoples Principle of Learning: Learning involves patience and time. Learning involves recognizing the consequences of one's actions.

Unit 2: Cell structure

Unit 2 is broken down in 4 sections: (1) cell structure; (2) cell function; (3) cell structural independence; and (4) cell membrane function.

Big Idea: The building blocks of our body are cells and biological molecules.

Core Competency: *Communication, Thinking*

First Peoples Principle of Learning: Learning involves recognizing the consequences of one's actions.

Unit 3: DNA controls the activity of cells

Unit 3 is broken down in 4 sections: (1) DNA structure and chemistry; (2) protein synthesis; (3) enzymes; and (4) biotechnology.

Big Idea: DNA controls all the activities of a cell

Core Competency: *Thinking*

First Peoples Principle of Learning: Learning involves recognizing the consequences of one's actions.

Unit 4: Digestive system

Unit 4 is broken down in 3 sections: (1) digestive structures; (2) digestive enzymes; and (3) insulin, glucagon, and the roles of the liver.

Big Idea: Providing energy to the body is the main job of digestion.

Core Competency: *Communication, Thinking*

First Peoples Principle of Learning: Learning involves recognizing the consequences of one's actions.

Unit 5: Respiratory system

Unit 5 is broken down in 3 sections: (1) respiratory structures; (2) inhalation and exhalation; and (3) gas exchanges.

Big Idea: Our lungs are the central organs for exchanging gases.

Core Competency: *Communication, Thinking*

First Peoples Principle of Learning: Learning involves recognizing the consequences of one's actions.

Unit 6: Circulatory system

Unit 6 is broken down in 3 sections: (1) respiratory structures; (2) inhalation and exhalation; and (3) gas exchanges.

Big Idea: Blood is the primary transportation within our bodies.

Core Competency: *Communication, Thinking*

First Peoples Principle of Learning: Learning involves recognizing the consequences of one's actions.

Unit 7: Nervous system

Unit 7 is broken down in 5 sections: (1) neurons; (2) impulse generation; (3) reflex arc; (4) the brain; and (5) peripheral nervous system.

Big Idea: The nervous system is the control center for our bodies.

Core Competency: *Communication, Thinking*

First Peoples Principle of Learning: Learning involves recognizing the consequences of one's actions.

Unit 8: Excretory system

Unit 8 is broken down in 5 sections: (1) urinary system; (2) flow of water; (3) the nephron; (4) structures; and (5) hormones.

Big Idea: After extracting energy, the body must remove the waste.

Core Competency: *Communication, Thinking*

First Peoples Principle of Learning: Learning involves recognizing the consequences of one's actions.

Unit 9: Excretory system

Unit 9 is broken down in 5 sections: (1) male structures; (2) testosterone; (3) female structure; (4) cycles; and (5) implantation.

Big Idea: Reproduction is the key to our history and future.

Core Competency: *Communication, Thinking*

First Peoples Principle of Learning: Learning involves recognizing the consequences of one's actions.

STUDENT LEARNING ACTIVITIES AND STRATEGIES:

- Course readings

ASSESSMENT:

The course will include many formative assessment opportunities where students will receive teacher feedback and have the opportunity to incorporate self-reflection and self-assessment tools. The formative tasks are designed to help students correct, hone, and improve on their work before being assessed. After each full submission of work, the teacher will provide feedback based on criteria and performance standards that can then be incorporated into the final summative assignment.

Summative assessment will take place after extensive formative assessment and be used on final performance tasks and tests throughout each unit. This course will be using specific rubrics for different tasks and students will have access to these rubrics before submission of the assignments. Formative:

- Teacher – student conferences (online or in person) to discuss drafts and progress.
- Online quizzes to check for completion and understanding of lessons.

Summative:
